# Environmentally Preferable Product Program (EPP)

- Cross service, multi-agency initiative
- To help DLA customers accomplish the goals and objectives outlined in Executive Orders, RCRA and other key legislation
- Increased visibility due to new reporting requirement in Sec. 314, FY03 Defense Authorization Bill
  - DLA to track and report annually to Congress on DoD procurements of EPP, to include percentages
  - First report due by March 1, 2004, on FY03



# Environmental Attributes

- Environmental Attribute Codes (ENAC) for NSN items in the Federal Logistics Information System (FLIS)
- Signifies that a product meets strict, definable environmental standards and criteria from an approved certifying organization
- Currently applied to roughly 1600 items managed by DLA and GSA
- DLA formed and chairs a Joint Group on Environmental Attributes (JGEnvAtt) to seek out and evaluate clearly definable environmental product criteria or 'attributes' from recognized environmental organizations
- JGEnvAtt process: Identify, evaluate and through a consensus building process, approve Environmental Attributes or criteria to be applied to products in the FCS.
  - Voting Members: DLA, Army, Navy, Air Force, Marine Corps, GSA
  - Advisors: EPA, USDA, DOE, OSD



# Environmental Attributes approved to date by the JGEnvAtt

- **Recycled Content**-- products that meet or exceed the specific product CPG: [Comprehensive Procurement Guideline - Recovered Materials Advisory Notices \(RMAN\)](#) as outlined on the [EPA website](#).
- **Energy Efficient** -- products that meet [DOE Energy-Efficient Products Standards](#) -- products in the top 25 percent of energy efficiency for all similar products, or at least 10% more efficient than required by DOE standards, or meets efficiency criteria of the EPA/FDOE Energy Star label.
- **Water Conserving** -- [Plumbing fixtures that meet or exceed the Department of Energy \(DOE\) Federal Energy Management Program \(FEMP\)](#) recommended performance standards for flow rates, and are in the upper 25% of energy efficiency of that product group.
- **Low VOC Content** – any product that meets the VOC content requirements established in the California South Coast Air Quality Management Source Specific Standards
- **Low Standby Power** -- products that use minimal power when in a [Low Standby mode](#), as outlined in [Executive Order 13221](#) as listed in the [Department of Energy Federal Energy Management Program \(FEMP\) listing of Standby Power Devices](#)
- **Asbestos Alternative** -- replacement for a product that normally contains asbestos and has less than 1.0 percent asbestos by weight or area (as determined using EPA Test method

  - API certified oil in your choice of 5W-30, 10W-30, 15W-40, 30 and 40.
  - No minimum orders.
  - Packaged in Quarts, 5 Gallon Containers, and 55 Gallon Drums.
  - World-wide delivery from Vendor to Customers
- **Closed Loop Re-refined Oil Program**
  - API certified oil in your choice of 30, 40, 10W-30 and 15W-40
  - Small minimum orders.
  - Includes pick up of your used oil for refining.
  - CONUS delivery of packaged and bulk products, available in Quarts, 5 Gallon Containers, 55 Gallon Drums, and bulk deliveries.

# Reclaimed Engine Coolant (aka Recycled Antifreeze)

- Conforms with EPA guidelines
- Might be purer since recycling process reduces chlorines from hard water
- Commercial Item Description that replaces 3 Mil Specs, specs same for virgin, recycled
- Army – 3 years ago, use recycled only, DLA to do automatic substitution
- Other Services -- similar directions

# Toner Cartridges

- EPA CPG item (non-paper office product)
- Used in laser printers, photocopiers, fax machines, and microphotographic printers
- When the toner is replaced, the cartridges can be returned to the manufacturer to be refilled, refurbished, and cleaned for resale.
- EPA recommends that agencies procure remanufacturing services for expended cartridges and, when such services are unavailable or not practicable, obtain remanufactured toner cartridges or new toner cartridges made with recovered materials from product vendors

# Bio-based Fuels (aka Biofuels)

- B20, a blend of 20% long chain fatty acids from vegetable oil and 80% low sulfur diesel fuel
- E85, a blend of 85% ethanol and 15% gasoline
- DLA's work with DOE on biofuels for Government fleets – began in 1999
- Driven by EO 13101 and 13149, Greening the Government Through Federal Fleet and Transportation Efficiency
  - Agencies to decrease petroleum consumption by 20% by 2005; 75% fleet to be alternatively fueled vehicles (AFV)
  - Biofuel use reduces regulated exhaust emissions and decreases petroleum imports



# Biofuels

- ASTM standard for E85, none for B20
- Work to establish quality requirements for B20 so fuel works comparable to diesel
- Procurement clause established
- GSA approved B20 procured by DLA
- USPS, DOE, USDA, Park Service
- B20 requirements:
  - 1.4M gallons (2001), 5M gallons (2002)

# Vehicular Battery Consignment Program

- Contract awarded April 2000 services all 50 states – current contractor is Exide
- Batteries included: 6TMF, 2HN, 4HN
- **New Low Price: The 6TMF battery price is \$72.92 for all sites (FY 2002 price).**
- Direct Vendor Delivery for sites with total of 120 or less per year – order on as needed basis through MILSTREP
- Consignment of 30 day supply for sites with more than 120 per year – over 200 sites – requires application
- Contractor takes away the unserviceables (disposals) on a one-for-one basis

# Exploratory Initiatives

- Asbestos elimination efforts
- Testing commercial biobased hydraulic fluid
  - 2 rounds so far for 2 mil specs – none satisfied
  - Looking at: 3<sup>rd</sup> round; reformulation; commercial equip
- Biobased Cutlery
  - DLA let R&D contract in 2002; Natick R&D performing functionality & safety testing
  - Tests show vast improvement since 1999
- Other: biodegradable plates, clam shells, food wraps, garbage bags; biobased adhesives

Our military and federal agency customers worldwide can buy Environmentally Preferable Products from DLA with the confidence of knowing that the Environmental Attribute or Characteristic criteria has been reviewed and approved by a consensus of the military services and federal agencies through the DLA chaired [Joint Group on Environmental Attributes](#). And vendors, manufacturers and suppliers selling environmentally preferable products to DLA have the confidence of knowing that if their products meet any of our [DLA Approved Environmental Attributes](#), those products will be highlighted in the Federal Catalog by a distinctive coding system and a "Green Tree" icon to make them readily identifiable to our customers.

# Defense Reutilization & Marketing Service (DRMS)

- Disposal of Hazardous property (waste or material) to maximize the use of each item and minimize the environmental risks and the costs associated with disposal
- Environmentally Preferable Electronics Demanufacturing Service
  - In four years, 100 million pounds processed through controlled dispositions
  - About 25% requires demilitarization



# Flow for Electronic Property

- DRMS Receipt of Excess Property
- Reutilization or Redistribution (within DoD)
- Transfer to Federal Agencies
- Donations to State & Local
- Sale by DRMS Commercial Venture Agent
- Demanufacturing
  - Commercial contracts
  - MOU with UNICOR



# Demanufacturing Concerns

- Environmental Protection
  - Electronics scrap sales to general public eliminated
  - Controlled disposal of:
    - Batteries of all types in electronics
    - Mercury switches
    - Lead, Chromium and Cadmium prevalent
  - Renewed Focus on leaded glass, keeping from landfill
  - Increased Recycling & solid waste diversion



# Demanufacturing Concerns

- Demil & Trade Security Controls
  - Ensure that Munitions List Items (MLI) requiring destruction are destroyed
  - Ensure that MLI/CCLI not requiring destruction is registered to prevent unauthorized disposition
  - Ensure that sensitive data is destroyed (Interim hard drive and storage media policy)



# Demanufacturing Segments

- **Military Unique property**
  - Demilitarization
  - Trade Security
  - Sensitivity of Data
- **More need for control and security**
  - National Safety
  - Unauthorized Use
  - Remanufacture risk
- **Commercially available property**
  - Environmental Protection overriding concern
  - More opportunity for reuse or sale
- **Some overlap occurs**



# Hazardous Material Information Resource System (HMIRS)

- DoD central repository for Material Safety Data Sheets (MSDS); including foreign language MSDS
- Assists Federal Government personnel who handle, store, transport, use, or dispose of hazardous materials – EPA, OSHA, DOT
- Online web or quarterly CD-ROM access
- Document submittal website for manufacturers and Government agencies
- Includes value-added info by Service-agency focal points: HAZCOM  
warning label & transpo





# DLA Environmental Reporting Logistics System (ERLS)

- Automated environmental tracking and reporting capability for hazardous, radioactive, and environmental items
- Begun in 1994 under PADUSD(ES) and DESCIM purview to meet reporting requirements of Executive Orders 12856 (completed 1998) and 12873 (P<sup>2</sup> module, completed 2000)
- (New) Perform functions required by Section 314 and OSD/OMB



# ERLS Affirmative Procurement Program Functions

- Daily contract and requisition information on environmental items
- Quarterly and annual reports on purchases and requisitions of items with recovered materials
- Ability to capture purchases of “non-green” counterparts vs. environmentally friendly
- (New) Report on web for services to view

# RCRA/Section 314 Reporting

- Reports automatically generated quarterly
- Report requisitions by for one quarter or year/year-to-date
- Quantity and dollar values for green vs. non-green items purchased/sold
- All items with environmental attribute codes – not just CPG items
- Service/Agency level summary or DODAAC detail reports
- Plan to make data available to field activity personnel – manage APP from field up – not HQ-down.
