

SECURITY COOPERATION LEGISLATIVE PROPOSALS

• EXPAND 15-DAY CONGRESSIONAL NOTIFICATION OF 36B SALES TO ALL ALLIED NATIONS, NOT JUST NATO, AUSTRALIA, JAPAN AND NEW ZEALAND

(POSSIBLE – Initiative Under Consideration)

- EXPAND 36B THRESHOLD TO COVER ADDITIONAL COUNTRIES
 - FY03 Foreign Assistance Authorization Bill raised thresholds for NATO, Australia, Japan and New Zealand (LIKELY- Discussions Continue)

SECURITY COOPERATION LEGISLATIVE PROPOSALS

 AMEND TITLE 10 USC TO AUTHORIZE DOD TO ESTABLISH DISCRETIONARY FMF AND IMET ACCOUNTS FOR COMBATANT COMMANDERS FOR DEVELOPING COUNTRIES SUPPORTING THE WAR ON TERRORISM.

•IMPROVE FLEXIBILITY OF DOD O&M FUNDS FOR DEFENSE ARTICLES, SERVICES AND TRAINING FOR DEVELOPING COUNTRIES SUPPORTING WAR ON TERRORISM.

(UNLIKELY – Doubt Congress will relinquish control. However, Train and Equip initiative may meet this need.)




