### **NDIA IPMD Health Metrics Committee** Analysis of Prior Year DCMA EVM Audits

NDIR AT THE HEART OF THE MISSION

- DCMA released a file on prior year Compliance Reviews data only
- It represented about 1/4 to 1/3 of the DCMA Audit data using DECM Test Metrics
- Latest DECM Threshold was used to normalize the data for comparisons
- Compliance data was selected to analyze first since it exhibited the most consistent data collected
- Data was cleansed so that Industry cannot tell the contractors or contracts being audited
- Data collected is Tracker UID, EVMSC Org, Analyst, CAGE, Contract Number, Service, Event, Guideline, DECM ID, DECM Version, DECM Threshold, X Value, Y Value, X/Y Result, CAR Boolean, CAR Number, CAR Level, Data Date, and Final Adjudication
- Compliance review data was comprised of 18 separate contractors and 27 unique contracts for Years 2019 through 2021

## **NDIA IPMD Health Metrics Committee** Analysis of Prior Year DCMA EVM Audits



- DCMA currently working the surveillance review data
- Since the data received is not based on Surveillance Reviews, the committee was not able to use to substantiate any DECM Test Metric Proposal Changes for this upcoming DCMA CCB
- DCMA wants the Health Metrics Committee to work with them on analyzing the data and validating what data they should collect ... This effort will need to continue after the Oct 2022 DCMA CCB
- DCMA team participation on data analysis of prior year DCMA EVM Audits will consist of James (Mike) Valley and the current rotated Acting Deputy Director of EVM
- DCMA is interested in doing a comparative analysis of the DoD Test Metrics versus the DOE Test Metrics

- DCMA will be holding their DECM CCB end of October.
- Industry DECM Test Metric Change Proposals must be submitted to the DCMA CCB by Monday, 10/10/2022
- DECM Test Metrics v6.0 are usually published 6 weeks after DCMA CCB
  - Mid Dec 2022 before Christmas break
