

Cost & Software Data Reporting (CSDR) Overview



- Cost & Software Data Reports are statutory CAPE-administered deliverables to support DoD cost estimates on major programs
 - <u>Contractor Cost Data Reports (CCDRs)</u>: "FlexFile" -- historically the DD 1921 series
 - <u>Other reports</u>: Software Resource Data Report (SRDR), Technical Data Report, Maintenance & Repair Parts Data Report, Contractor Business Data Report
- Required for contracts and subcontracts >\$50M across all acquisition pathways
 - Applicable for all contract types including FFP
 - May be required for "high-interest" efforts in \$20M to \$50M range
- CSDR report frequency is typically annual or less
 - Contract-specific CSDR plan outlining the WBS, formats, & reporting frequency should appear as an attachment in the RFP/contract

Industry CSDR deliverables are critical to DoD's ability to develop & justify reasonable budgets for major acquisition programs




Contractor Cost Data Reports (CCDRs)

- Provide financial actuals & projections with fields useful for DoD cost estimators
 - MIL-STD-881-compliant product-oriented WBS
 - Recurring/Non-Recurring
 - Effort & costs with functional breakdown in standard categories
 - Actual costs/fee vice price

FlexFiles

- In 2019, instituted as default format over DD 1921
 - Form factor is JavaScript Object Notation (JSON) schema similar to IPMDAR
- Key advantages over DD1921 series forms, adding:
 - Time-phasing
 - Account-level data below the WBS
 - Industry native functional categories

Top CSDR Challenges – CAPE Perspective



- 1. Facilitating communication on reporting expectations & tailoring before it's too late
 - Goal is always to strike balance between standardized reporting to aid major DoD decisions and the cost of providing reporting
 - Attempts to facilitate conversation prior to contract award are not always successful or practical
- 2. Determining accurate reporting compliance status & assisting stakeholders in correcting issues for late reports
 - On average only receive ~70% of expected reporting volume in any given month
 - Sometimes difficult to understand whether "late" reports are due to contracting issues or fact of life program changes
- 3. Providing guidance/training resources to aid industry on relatively infrequent CDRL requirement
 - Difficult to balance general training materials with a broad audience with the need for program or contractspecific discussions

We require industry data provider feedback to be successful – What are industry's top CSDR challenges?

CSDR Focus Group & Training



- CSDR Virtual Training & Webinars
 - General group training held on monthly basis on various topics (~50-150 attendees)
 - We can consider tailored training on case-by-case basis, but we're always available to discuss contractspecific details
- Annual CSDR Focus Group
 - Forum for government & industry stakeholders to share knowledge, provide feedback, & discuss improvements
 - This year will be held October 29th-30th at Lockheed Martin Global Vision Center in Crystal City, VA
